



# M6 Stage 1

**Earthwork activities at Ador Park Precinct and McCarthy Reserve, Rockdale from Monday 21 September**



We are underway with our work to build your new and upgraded community facilities as part of the M6 Stage 1 project.

From Monday 21 September activity will increase as we commence earthwork activities at Ador Park Precinct and McCarthy Reserve.

## What does our work involve?

Our work involves excavating and relocating materials within our site as well as bringing materials to and from the site.

We will use light vehicles, excavators, graders, rollers and compactors, watercarts and trucks to complete this work.

## Our work schedule

This stage of our work will take up to eight weeks to complete, weather permitting.

Our work hours are:

- **7am to 6pm, Monday to Friday**
- **8am to 1pm Saturday**

We will not be working public holidays.

## How will our work affect you?

We will need to use an excavator and other equipment, so we expect there to be some noise associated with our work.

We will also help to reduce noise by using non-tonal reversing alarms (quackers) on all machinery and by turning off equipment and vehicles when they are not being used and minimising reversing where possible.

## Supporting our community

Currently infrastructure construction projects are considered essential to the economy and will continue as planned across the city and the state.

The M6 Stage 1 project will deliver 5,300 jobs and support the local economy.

The safety and wellbeing of our workforce and the wider community is our highest priority. Our people are following hygiene and appropriate social distancing measures and will continue to do so.
