


M6 Stage 1

Site investigations at Rockdale Bicentennial Park, Rockdale from Monday 9 November



We will continue to keep you updated as the project progresses.

What does our work involve?

We will be scanning and drilling into the ground to gather information about the underground conditions.

Our work area is shown on the map over the page.

Our work schedule

We will have one crew working at each location at a time, moving progressively throughout Rockdale Bicentennial Park. We expect to be at each location for up to two days.

Work hours are between:

Monday to Friday, 7am to 5pm.

We expect the work to take up to two weeks to complete, weather permitting.

How will our work affect you?

Our work may be a little noisy as we will be drilling into the ground and moving our equipment around.

We will help to reduce noise by using low noise reversing alarms on all machinery and turning off equipment and vehicles when they are not being used.



We will be using light vehicles, a drilling rig and hand tools during our work.

Once complete we will reinstate the area by replacing soil and relaying grass. This may lead to raised ground levels in some areas for a short period of time so please be careful.

Traffic changes and pedestrian access

There will be fencing in place around our work. Please take care when navigating around our work area.

About the M6 Stage 1 project

The M6 Stage 1 project will provide a new four kilometre underground motorway connection between the M8 at Arncliffe and President Avenue, Kogarah, connecting southern Sydney to the motorways network.

When the project is complete, the M6 Stage 1 will remove 2,000 trucks a day from surface roads and help ease congestion – returning local streets to communities.

Currently, infrastructure construction projects are considered essential to the economy and will continue as planned across the city and the state.

The safety and wellbeing of our workforce and the wider community is our highest priority. Our people are following hygiene and appropriate social distancing measures and will continue to do so.
