Community Notification

The Transport Access Program is a NSW Government initiative to provide a better experience for public transport customers by delivering accessible, modern, secure and integrated transport infrastructure.

Planning approval received and start of construction

Transport for NSW is excited to announce that planning approval has been granted for the alterations required to enable the reinstatement of Millthorpe Station as an on-request train stop.

Planning approval follows on from the recent heritage approval granted for the project in August 2018.

A construction contract has been awarded to carry out the works, and activities are starting next week.

The project includes:

- a simple platform extension which will have an accessible ramp

- features include a new platform approximately 15m long, additional lighting, an information board, tactile indicators and a help point
- a wooden picket fencing will be installed on the new platform extension.

The platform extension will be a lightweight construction of concrete and structural steel elements, and will be installed parallel to the existing heritage platform.

As a result of community consultation, the current Millthorpe Station sign (hidden behind undergrowth) will remain on the original platform.

Site establishment

From the week commencing **17 September 2018**, the contractor will be visiting the site to coordinate the commencement of site establishment. This will include a site compound, shed and area for the storage of equipment and materials. This will be established within the overflow car park.

What you might notice

You might notice the delivery and installation of site fencing, and the application of banner mesh around the site to demarcate construction activities from public areas.

Once the site fencing is set up, construction material and equipment will be delivered to enable the commencement of major construction works. Environmental controls will also be put in place at this stage.

Temporary changes to parking

During construction, the site compound will be set up in the overflow car park. A portion of this space will be temporarily unavailable for use during community events until the project is complete.

Construction activities throughout the project duration

- Piling and establishment of foundation
- Pouring concrete footings
- Install steel frames
- Install new fencing around the platform extension
- Install handrails, platform tactiles, information boards.

Following the completion of the construction works, Sydney Trains will commence work on the station to enable services to recommence at the station, including the connection of the help point and car markers for the trains.

It is expected that train services will recommence at Millthorpe in March 2019.

Standard working hours

Work will be completed during standard work hours, which are **Monday to Friday from 7am to 6pm** and **Saturdays from 8am to 1pm**. Notification will be given to the community prior to any works which are scheduled outside of standard working hours.
